We would like to increase club participation by reducing the cost of clubs and encouraging staff members to lead a club after school. In 2019/20 we participated in 10 competitive sporting events against local schools and were booked on to another 20 plus events. Develop opportunities for play and physical activity through improving the school grounds. In 2020-2021 extra curricular clubs will be provided as and when COVID restrictions allow. These will be bubble based if necessary. The school will investigate hosting Fit and Fed holiday camps at Easter/summer 2021. Opportunities to encourage fitness will be explored eg – prioritising the delivery of PE, well-being and outdoor learning.
